## TERMS AND CONDITIONS OF INSTRUCTION

1. In these "Terms and Conditions of Instruction," Yale Aviation, Inc. is called Aviation.
2. Aviation in its discretion at any time may suspend or expell any student for any cause which Aviation in its sole discretion deems sufficient without liability for return of matriculation fee, tuition, or other payments.
3. Each student shall pay a matriculation fee as specified by the Directors at the time this Application for Instruction is filed.
4. Each student shall pay a monthly tuition free in an amount specified by the Directors, each monthly payment to be made within five days after the first day of each calendar month.
5. Each student shall pay a fee for each hour of instruction and a fee for each hour of flight according to the schedule of fees stipulated from time to time by the Directors. Instruction and flight fees will be billed to each student at the end of each month and must be paid within ten days after the date of mailing of the bill. Late payments will be subject to finance charge equal to 1.5% per month. In the event a student defaults on his or her obligations to Aviation, the student shall pay all costs of collection, including reasonable attorneys fees.
6. No student whose accounts are in arrears may receive instruction or engage in flight except with the approval of the Board of Directors.
7. Each student shall be responsible for the safe operation of all equipment of Aviation used by him/her and shall adhere to the Federal Aviation Regulations and the Flight Regulations of Aviation. If damage to any such equipment is proximately caused by an act or omission of a student, the student (and his parent/legal guardian if he/she is a minor, but only in respect of the separate estate of the minor) shall be liable to Aviation for the amount of damage sustained, provided, however, that such liability shall be reduced by any amounts not recovered as insurance proceeds.
8. If any student in the discretionary determination of the Board of Directors or its designee causes loss or damage to the Corporation or to its equipment or to any student or instructor by reason of the gross negligence or willful misconduct or willful violation of any law, ordinance or governmental regulation or any rule of Aviation, or while under the influence of intoxicating liquor or drugs, the student (and his/her parent/legal guardian if he/she is a minor, but only in respect of the separate estate of the minor) shall be liable to Aviation for all such loss or damage.
9. Aviation agrees to inform any student at any time upon the request of the student concerning the insurance then being maintained by Aviation.
10. Aviation is legally independent of Yale University, and Yale University has no responsibility for any act or omission of Aviation and no liability to any student for any loss or injury incurred in connection with the program of Aviation.
11. Aviation reserves the right at any time and from time to time to amend any provision of these Terms and Conditions of Instruction. Such amendment shall be effective as of its date when consented to by the student, and (if the student is a minor) by the student's parent or legal guardian.
